### Medium

ATCC® Medium 196: Yeast malt extract agar

### Growth Conditions

**Temperature:** 26.0°C

### Propagation Procedure

1. Open vial according to the enclosed instructions.
2. Using a single tube of ISP #1 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube and mix well.
4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.
5. Incubate all tubes and plate at 26°C for 48 hours.

## Notes

Vegetative cells are yellow to brown. Aerial mycelium is white, dry, and abundant. Sporophores are straight, spores are spherical and oval.
