Propagation Procedure

1. Open the vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1 mL with a Pasteur or 1.0 mL pipette. Rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
5. Incubate all tubes and plate at 26°C for 24 hours.

Notes

Vogesella indigofera is a Gram-negative rod that occurs singly or in pairs, very rarely in chains.

Colonies are blue with a metallic sheen of yellow color. A dark blue print remains in the agar after a colony is scraped off.
