Allow to thaw at room temperature.

Quality Control Information

1. Yeast genomic DNA is provided as a suspension frozen at -70°C.
2. Integrity of DNA was determined by electrophoresis
3. on a 1% agarose gel stained with ethidium bromide, and was found to be intact and of high molecular weight.
4. A260/280 was within acceptable limits (1.8 to 2.0).
