Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #814 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use 0.2 mL of the suspension to inoculate a #814 slant, and/or 0.1 mL for a plate.
5. Incubate all tubes and plate at 37°C with 5% CO₂. Growth should occur in 24 to 48 hours. Assure that screw caps are loose during incubation period.

Notes

Colonies on #814 agar are small, entire, smooth, low convex, and glistening.

Strain will also grow on Brain Heart Infusion (BD 237500) and Brain Heart Infusion Agar (BD 241830).
