**Product Description:** Used for testing disinfectants and antimicrobial handwashing formulations. Quality control strain of ENDO-SPOR™ hydrogen peroxide sterilization.

## Propagation

### Medium

ATCC® Medium 3: Nutrient agar or nutrient broth

### Growth Conditions

**Temperature:** 30°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
5. Incubate the tubes and plate at 30°C for 24 hours.

## Notes

Growth is poor in broth incubated statically but heavy on agar. Colony variation may be observed and is typical for this strain.
