### Preparation Procedure

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with molecular grade H<sub>2</sub>O. DNA is dried in Tris
2. Place vial at 37°C for 1 hour or at +2°C to 8°C overnight.
3. For more complete rehydration and to fully recover DNA incubate the sample at 65°C for 1 hour or overnight at 4°C

### Quality Control Information

1. Fungal genomic DNA is provided in a dried form. Store at +2°C to 8°C upon receipt. Store at -20°C if stored for more than 6 months). **Note:** Do not store in freezers with a defrost cycle. This will expose the product to increased temperatures.
2. Concentration by PicoGreen® measurement was found to be approximately 5 µg.
3. Purity: OD<sub>260</sub>/OD<sub>280</sub> ratio.
4. Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with ethidium bromide, and was found to be of high molecular weight.
5. No RNA was detected by electrophoresis.
6. Functional activity was confirmed by PCR amplification of approximately 1500 base pairs fragment of rRNA gene cluster including ITS1-5.8S-ITS2 region.
7. Identity confirmed by sequencing of ITS1, 5.8S gene and ITS2 regions of ribosomal ribosomal RNA (~500 base pairs).

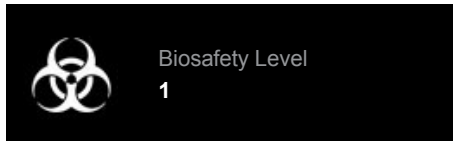
