Propagation Procedure

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet using approximately 0.5 mL of #3 broth. Aseptically transfer the entire contents to a tube of 5-6 mL #3 broth. Additional broth tubes can be inoculated by transferring 0.5 mL from this primary broth tube to secondary broth tubes.
3. Use several drops of the primary broth to inoculate a #3 plate and/or slant.
4. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Referred to as the type strain (J. Bacteriol. 4: 429-503, 1919). However this is not one of the strains on which Morgan based his original description of this organism, hence it cannot be designated as the type.
