ATCC® Medium 1252: Reinforced Clostridial medium (Oxoid CM149) with sodium lactate (60% solution) at a concentration of 1.5%

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Growth Conditions

Temperature: 37°C

Atmosphere: Anaerobic gas mixture

Propagation Procedure

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 ml of #1252 broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. A slant and a pre-reduced blood plate may also be inoculated with 0.1 ml each of the cell suspension. An aerobic blood plate may also be streaked to check for purity.
4. Incubate tubes and plate under anaerobic conditions at 37°C. Incubate blood plate aerobically at 37°C.
5. Within 24 to 48 hours, growth is evident on anaerobic media. No growth should appear on the aerobic plate.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Within 24 to 48 hours, growth is evident by turbidity in the broth and colonies on the agar slant. After two days, the anaerobic plate will have small colonies that are circular, entire, convex, smooth, cream, and translucent. The aerobic plate should show no sign of aerobic growth.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
