#### Preparation Procedure

1. Rehydrate contents of vial with 1X TE or molecular grade H<sub>2</sub>O.
2. Place vial at 55°C for 30 minutes to 1 hour or at 22°C overnight.

#### Quality Control Information

1. Protist genomic DNA is provided in a dried form. Store at 4°C upon receipt.
2. Concentration by PicoGreen® measurement was found to be approximately 2 µg.
3. Purity: OD<sub>260</sub>/OD<sub>280</sub> ratio.
4. Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe, and was found to be intact and of high molecular weight.
5. No RNA was detected by electrophoresis.
6. Functional activity was confirmed by PCR amplification of the 18S ribosomal RNA gene.
7. Identity confirmed by sequencing of the 18S ribosomal RNA gene.
