## Propagation

### Medium

ATCC® Medium 2722: Supplemented Tryptic Soy Broth/Agar

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Anaerobic gas mixture, 80% N<sub>2</sub>-10% CO<sub>2</sub>-10% H<sub>2</sub>

### Propagation Procedure

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #2722 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #2722 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 3-5 days. Incubate one agar plate aerobically at 37°C to check for contamination.

### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

## Notes

Anerobe Systems PY + Glucose broth (AS-822) produces the best growth for this organism. If #2722 broth is used, 1% vol of Glucose should be added in order to ensure adequate growth.

Colonies on pre-reduced #260 appear circular, spreading, thin, and film-like with wrinkled centers.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
