A *Bacillus subtilis*/*Escherichia coli* shuttle vector.

Designation: pBS42 plasmid in *E. coli*

Propagation

Aseptically add 0.3 to 0.4 ml of liquid medium to the freeze-dried pellet and mix well. Transfer 100 μ L to a test tube containing 5 mL LB + 10 mg/ml of chloramphenicol. A loopful of culture can also be streaked on an LB + chloramphenicol agar plate. Incubate cultures at 37°C. Isolate DNA using standard plasmid preparation procedures.
