ATCC® Medium 416: Lactobacilli MRS Agar/Broth

### Growth Conditions

**Temperature:** 34.0°C

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
5. Incubate tubes and plate at 37°C aerobically or in an atmosphere of 5% CO<sub>2</sub> for 48 hours. Loosen screw caps of all test tubes during the incubation period.

## Notes

Colonies on #416 agar are circular, entire to erose/irregular, and opaque with a dull sheen.
