### Medium

ATCC® Medium 2107: Modified Reinforced Clostridial Agar/Broth Medium (pre-reduced)

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Anaerobic gas mixture 80% N<sub>2</sub> -10% CO<sub>2</sub> -10% H<sub>2</sub>

### Propagation Procedure

1. Thaw the frozen vial under anaerobic conditions.
2. Under anaerobic conditions, transfer the entire contents of the thawed vial into a single tube (5-6 ml) of #2107 broth. Mix well.
3. Additional tubes of broth may be inoculated with 0.5 ml each from the suspension and 0.1 ml may be inoculated onto a slant. Streak several blood plates for colony morphology and purity.
4. Incubate the tubes and plate under anaerobic conditions at 37°C for 24 to 48 hours. Incubate the purity plate aerobically at 37°C. Turbid growth is evident in the broth at 24 to 48 hours.

### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

## Notes

Colonies on Brucella Blood agar are irregular, undulate, glistening, smooth, grey, and flat. Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions has not been met and oxidation has occurred. Medium should be discarded.
