## Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #2167 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
5. Incubate all tubes and plate at 37°C with 5% CO<sub>2</sub> for 48 hours. Assure that screw caps are loose during incubation period.

## Notes

Colonies on ATCC #814 are entire, glistening, circular, smooth, grey, and raised  
Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #2167 broths are not available, but it will not support growth as well as the HTM broth.
