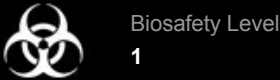

**Product Description:** This is a host strain with well-characterized restriction maps for NotI, SfiI, XbaI and BlnI. It can be used as a molecular size marker for pulsed-field gel electrophoresis (J. Mol. Biol. 232: 419-445, 1993). Derived from the parent strain W1485 by curing of the F plasmid. (J. Bacteriol. 174: 558-567, 1992). Genbank numbers associated with this host: L10328, M87049, L19201, U00006, X54797, X64592, X72920.

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #1065 broth. Additional test tubes can be inoculated by transferring 0.1 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #1065 plate and/or #1065 agar slant.
4. Incubate at 37°C for 24 hours.
