### Medium

ATCC® Medium 3: Nutrient agar or nutrient broth

### Growth Conditions

**Temperature:** 30.0°C

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
5. Incubate the tubes and plate at 30°C for 72 hours.

## Notes

Colonies are circular with an entire margin and a convex elevation. Colonies are smooth, glistening, and translucent with a yellow color that deepens with age. Cells are short to medium tapered rods occurring singly and in pairs.
