**Product Description:** This strain is vancomycin-sensitive and teicoplanin-sensitive. This strain is also cited to be gentamicin-resistant and streptomycin-sensitive (Spiegel CA, J Clin Microbiol 26, 1988; Spiegel CA & Huycke M, Arch Intern Med 149, 1989).

### Medium

ATCC® Medium 44: Brain Heart Infusion Agar/Broth

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate at 37°C for 24 hours.
