## Propagation

### Medium

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37.0°C

**Atmosphere:** 5% CO<sub>2</sub>

### Propagation Procedure

2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours in an atmosphere of 5% CO<sub>2</sub>. Loosen the screw caps during the incubation time.

## Notes

Colonies on #260 plates are circular, entire, convex, smooth, and translucent. Cells are straight to slightly curved rods that occur singly and in pairs.

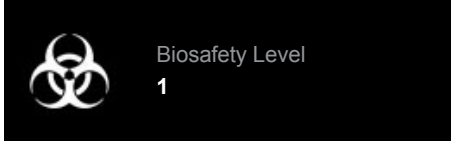
