SAFETY PRECAUTION

2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

Comments

Restriction digests of the clone give the following sizes (kb): EcoRI--9.6, 3.3; HindIII--4.2, 2.8, 2.6, 1.8, 1.35; KpnI--13.0.

The insert contains the following restriction sites (approximate kb from the end upstream of *ccrA*): HindIII--4.3, KpnI--4.8. The latter site interrupts the gene.

The vector is a derivative of pMK16 deleted for the carboxy terminal half of the tetR marker and has had the small EcoRI/BamHI fragment replaced with the MCS-containing EcoRI/BamHI fragment from plink 322.

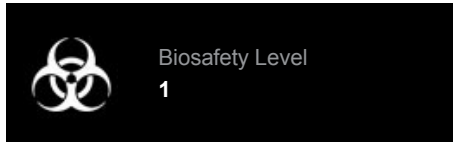
