**Temperature:** 28.0°C  
**Atmosphere:** Aerobic

**Propagation Procedure**

1. Open the vial according to enclosed instructions.
2. From a tube of #2138 broth (5 to 6 ml), withdraw approximately 0.5 with a sterile pipette; add this medium to the vial to rehydrate the entire pellet.
3. Aseptically transfer the contents of the vial into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #2138 agar slant and/or plate.
5. Incubate all tubes and plate at 28°C for 24-48 hours.

## Notes

*Silicibacter pomeroyi* is a very small Gram-negative rod that is motile. Colonies on #2138 agar are circular, entire, translucent and raised. Under a dissecting microscope the colonies have a silvery appearance like drops of mercury.
