### Description

A *Pseudomonas/E. coli* shuttle vector constructed by ligating pCN40 (ATCC#77097) and pUC18 which had been linearized with KpnI. It retains the mobilization site of pBR322-derived vectors and can be mobilized if suitable functions are provided in trans. The vector contains the basic replicon of pPS10 which has been sequenced (EMBL accession number X58896). The repA portion is flanked by EcoRI sites (nt 536 and 1500), with the site at nt 536 between the repA promoter and coding sequences.

### Propagation

Transfer a loopful to a test tube containing 5 mL LB+50mg/mL of ampicillin broth. A loopful of culture can also be streaked on an LB + amp agar plate. Incubate cultures at 37°C. Isolate DNA using standard plasmid preparation procedures.
