This is an expression vector. It permits high copy number and production of proteins initiated at the ATG of beta-galactosidase. The order of the major features in the plasmid is: pMB1 ori EcoRI trc promoter lacZ/NcoI PstI HindIII ampR. Protein Expr. Purif. 3: 332-336, 1992.

### Propagation

Transfer a loopful to a test tube containing 5 mL LB+50mg/mL of ampicillin broth. A loopful of culture can also be streaked on an LB + amp agar plate. Incubate cultures at 37°C. Isolate DNA using standard plasmid preparation procedures.
