## Description

This is a shuttle vector transforming *Schizosaccharomyces pombe* at high efficiency. It is suitable for generating nested deletions, DNA sequencing, and producing riboprobes. It permits visual detection of recombinants by lacZalpha complementation. It was constructed from pRS305 by inserting a 1.2 kb EcoRI fragment containing ares1 into the AatII site. The NdeI site in ars1 was removed. - Curr. Genet. 23: 547-548, 1993.
