

### **Preparation Procedure**

Centrifuge tube prior to opening to prevent loss of pelleted material

- 1. Rehydrate contents of vial with molecular grade H<sub>2</sub>O.
- 2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
- For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while
  rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in ≥250 µL may give better
  results



## **Quality Control Information**

- Bacterial genomic DNA is provided in a dried form. Store at 2°C to 8°C upon receipt. Store at -20°C if stored for more than 6 months. Note: Do not store in freezers with a defrost cycle. This will expose the product to increased temperatures.
- 2. Total DNA by PicoGreen<sup>®</sup> measurement was found to be approximately 5 μg.
- 3. Purity:  $OD_{260}/OD_{280}$  ratio.
- Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe<sup>™</sup>, and was found to be of high molecular weight.
- 5. No RNA was detected by electrophoresis.
- 6. Functional activity was confirmed by PCR amplification 16S ribosomal RNA gene.
- 7. Identity confirmed by sequencing of 16S ribosomal RNA gene (first ~ 500 base pairs).
