### Description

This is a yeast integrative vector with the LEU2 marker for selection in *Saccharomyces cerevisiae*, a beta-galactosidase reporter system for visual detection of recombinants, promoters for transcription *in vitro* and an extensive polylinker flanked by BssHII sites.

### Propagation

1. Open vial according to instructions. 2. aseptically add 0.3 to 0.4 mL of liquid medium to the freeze-dried pellet and mix well. Transfer 100 uL to a test tube containing 5 mL LB+ ampicillin (50-100 ug/mL). A loopful of culture can also be streaked on an agar plate of the same. Incubate cultures at 37<sup>0</sup> C. 3. Isolate DNA using standard plasmid preparation procedures.
