### Description

One of 9 shuttle vectors (ATCC 87585 87593) allowing lacZ detection of cloned inserts and containing the pUC19 MCS with all 10 cloning sites unique. Vectors differ in mode of replication (YE, YC or YI-type) and yeast marker (LEU2, URA3 or TRP1). This is a YE-type (yeast episomal) vector with the TRP1 marker. The HindIII, PstI and XbaI restriction sites from the TRP1 gene of *S. cerevisiae* were removed by using oligo-directed mutagenesis.

### Propagation

1. Open vial according to instructions. 2. aseptically add 0.3 to 0.4 mL of liquid medium to the freeze-dried pellet and mix well. Transfer 100  $\mu$ L to a test tube containing 5 mL LB+ ampicillin (50-100  $\mu$ g/mL). A loopful of culture can also be streaked on an agar plate of the same. Incubate cultures at 37<sup>0</sup>C. 3. Isolate DNA using standard plasmid preparation procedures.
