

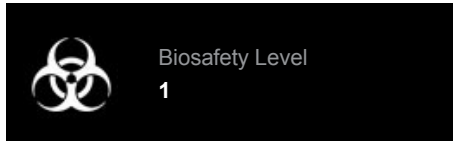

DNA was isolated from oocysts of *Cryptosporidium parvum*, GCH1 isolate, obtained from the feces of an AIDS patient by Dr. Jeff Griffiths at Tufts University in 1991. Since that time, oocysts have been propagated in experimentally infected calves.

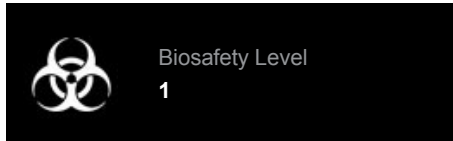
