## Description

This is a Rous Sarcoma (RSV) derived vector (5' LTR, gag, pol and 5' env), for ligation with avian retroviral expression vectors (ATCC# 87699 87701) to create proviral DNA capable of producing replication competent recombinant virus. The vector can be linearized with Sall for ligation to one of the RSV-derived expression vectors. The parental plasmid pSR-REP which encodes pol, derived from the Schmidt-Ruppin subgroup A strain of RSV, was described in Cell 34: 597-607, 1983. The pol sequence is derived from the Bryan strain of RSV and is more efficient in virus production after transfection.

## Propagation

1. Open vial according to instructions. 2. aseptically add 0.3 to 0.4 mL of liquid medium to the freeze-dried pellet and mix well. Transfer 100  $\mu$ L to a test tube containing 5 mL LB+ ampicillin (50-100  $\mu$ g/mL). A loopful of culture can also be streaked on an agar plate of the same. Incubate cultures at 37<sup>0</sup>C. 3. Isolate DNA using standard plasmid preparation procedures.
