### Description

This vector overproduces yeast truncated cystathionine beta-synthase (CBS). The truncated version was made by using PCR to insert two nonsense codons (TAA and TAG) after the site encoding the residue 353 amino acid of the full length CBS (F-CBS) gene on pF-SEC (ATCC# 87791). Biochemistry 39: 10548-10556, 2000

### Propagation

Transfer a loopful to a test tube containing 5 mL LB+50mg/mL of ampicillin broth. A loopful of culture can also be streaked on an LB + amp agar plate. Incubate cultures at 37° C. Isolate DNA using standard plasmid preparation procedures.
