## Description

This plasmid contains two fragments from the HO promoter inserted into pUC21-NotI polylinker along with the kanMX selectable marker. It allows for targeted integration at the HO locus.

**Designation:** HO-poly-KanMX4-HO

## Propagation

1. Open vial according to instructions.
2. Aseptically transfer a loopful to a test tube containing 5 mL LB+50 µg/mL of ampicillin broth. A loopful of culture can also be streaked on an LB + amp agar plate. Incubate cultures at 37°C.
3. Isolate DNA using standard plasmid preparation procedures.
