Preparation Procedure

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with molecular grade H₂O.

DNA is dried in 1X Tris buffer.

2. Place vial at 37°C for 1 hour or at +2°C to 8°C overnight.

3. For more complete rehydration and to fully recover DNA incubate the sample overnight at 4°C while rocking, then incubate for 1 hour at 65°C.

Quality Control Information

1. Fungal genomic DNA is provided in a dried form. Store at +2°C to 8°C upon receipt. Store at -20°C if stored for more than 6 months).

Note: Do not store in freezers with a defrost cycle. This will expose the product to increased temperatures.

2. Concentration by PicoGreen® measurement was found to be approximately 2 mg.

3. Purity: OD₂₆₀/OD₂₈₀ ratio.

4. Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBER Safe™, and was found to be of high molecular weight.

5. No RNA was detected by electrophoresis.

6. Functional activity was confirmed by PCR amplification of approximately 1500 base pairs fragment of rRNA gene cluster including ITS1-5.8S-ITS2 region.

7. Identity confirmed by sequencing of ITS1, 5.8Sgene and ITS2 regions of ribosomal RNA (~ 500 base pairs).

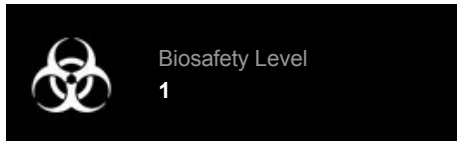
