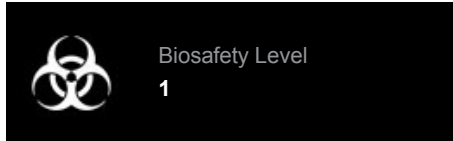

Genomic DNA isolated from *Streptococcus pyogenes* MGAS 6180. This bacterial strain is also available as ATCC® Catalog No. BAA-1064™.

## Preparation Procedure

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with molecular grade H<sub>2</sub>O.
2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
3. For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in ≥250 µL may give better results.

## Quality Control Information

1. Bacterial genomic DNA is provided in a dried form. Store at 2°C to 8°C upon receipt. Store at -20°C if stored for more than 6 months. **Note:** Do not store in freezers with a defrost cycle. This will expose the product to increased temperatures.
2. Total DNA by PicoGreen® measurement was found to be approximately 5 µg.
3. Purity: OD<sub>260</sub>/OD<sub>280</sub> ratio.
4. Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe™, and was found to be of high molecular weight.
5. No RNA was detected by electrophoresis.
6. Functional activity was confirmed by PCR amplification 16S ribosomal RNA gene.
7. Identity confirmed by sequencing of 16S ribosomal RNA gene (first ~ 500 base pairs).

## Biosafety Level: 1

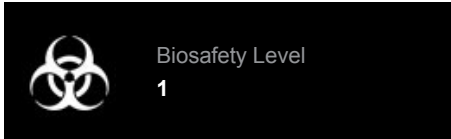
