Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Two colony types observed on #18 agar are 1) entire, glistening, circular, smooth, opaque, convex, and mucoid, and 2) entire, glistening, circular, smooth, translucent, and low convex.

This item is not ideal for individual antibiotic resistance testing. For a culture with a consistent detailed antibiotic pattern, we recommend ordering the *Klebsiella pneumoniae* QC strains listed in the CLSI manual.
