Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies on #18 plates are circular, entire, smooth, low convex, and cream colored. This organism displays multiple colony types on MacConkey agar. The primary colony type is positive for lactose fermentation, while the secondary is negative. Biochemical characterization of the individual colony types by Vitek, as well as genotypic characterization by ribotyping and PCR have determined they are the same. This strain was confirmed by PCR to carry the *eae* and *stx2* genes (*stx1*-, *stx2*+, *eae*+).
