**Product Description:** Ampicillin-resistant, non-spore former. Type strain.

## Propagation

### Medium

ATCC® Medium 3: Nutrient agar or nutrient broth

### Growth Conditions

**Temperature:** 30°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open thawed vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #3 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #3 plate and/or #3 agar slant.
4. Incubate at 30°C for 24-48 hours.

## Notes

Colonies on #3 agar after 48 hours are circular, entire, smooth, translucent, and low-convex.

The depositor states that this strain is ampicillin resistant; however, this has not been confirmed by our testing.
