### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Microaerophilic

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #416 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Incubate the tubes at 37°C for 48 to 72 hours under microaerophilic conditions. Loosen the screw caps during incubation period.
5. After growth is achieved, use several drops of the suspension to inoculate a #416 agar slant and/or plate. Incubate under above conditions.

## Notes

Grows best in broth. Growth on agar is very poor at best.
