Propagation Procedure

- Using a single tube of #336 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- Aseptically transfer this aliquot back into the broth tube. Mix well.
- Use several drops of the suspension to inoculate a #336 agar slant and/or plate.
- Incubate the tubes and plate at 28°C for 24-48 hours.

Notes

On #336 plates colonies are white, opaque with lobate edges and dry.
