## Propagation

### Medium

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Atmosphere:** air, 95%; carbon dioxide (CO<sub>2</sub>), 5%  
**Temperature:** 37.0°C

### Propagation Procedure

- Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- Aseptically transfer this aliquot back into the broth tube. Mix well.
- Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- Incubate the tubes and plate at 37°C for 24 hours.

## Notes

Colonies on #260 plates are entire, glistening, circular, smooth, flat, and produce a-hemolysis. Additional information on this culture is available on the ATCC web site at [www.atcc.org](http://www.atcc.org).

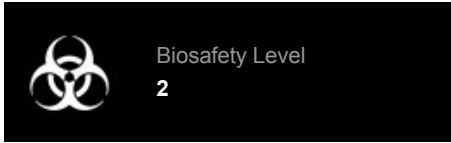
