## Propagation

### Medium

ATCC® Medium 2: Marine agar 2216 or marine broth 2216

### Growth Conditions

**Temperature:** 15.0°C

**Atmosphere:** Aerobic

### Propagation Procedure

- Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- Aseptically transfer this aliquot back into the broth tube. Mix well.
- Use several drops of the suspension to inoculate a second broth tube as well as a #2 agar slant and/or plate.
- Incubate the tubes and plate at 15°C for 48-72 hours.

## Notes

Colonies on #2 plates are small, circular, slightly raised, translucent and glistening. NaCl is required for growth (3-5%). Cells are Gram-negative and rod-shaped (*see below*).



Cells at 1000X after 68 hours of incubation at 15°C.

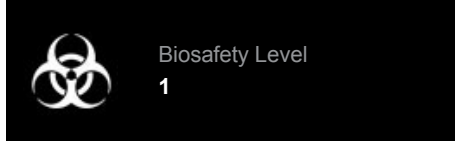
