## SAFETY PRECAUTION

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below  $-130^{\circ}\text{C}$ , preferably in liquid nitrogen vapor, until ready for use.

## Handling Procedure for Frozen Cells

### Handling Procedure for Frozen Cells

To insure the highest level of viability, thaw the vial and initiate the culture as soon as possible upon receipt. If upon arrival, continued storage of the frozen culture is necessary, it should be stored in liquid nitrogen vapor phase and not at  $-70^{\circ}\text{C}$ . Storage at  $-70^{\circ}\text{C}$  will result in loss of viability.

## Handling Procedure for Flask Cultures

### Handling Procedure for Flask Cultures

The flask was seeded with cells (see specific batch information), grown, and completely filled with medium at ATCC to prevent loss of cells during shipping.

1. Upon receipt visually examine the culture for macroscopic evidence of any microbial contamination. Using an inverted microscope (preferably equipped with phase-contrast optics), carefully check for any evidence of microbial contamination
2. Incubate the flask in an upright position for several hours at  $37^{\circ}\text{C}$ . After the temperature has equilibrated, aseptically remove the entire contents of the flask and centrifuge at 125 xg for 5 to 10 minutes. Remove shipping medium and save for reuse. Resuspend the cell pellet in 10 mL of this medium.
3. From this cell suspension remove a sample for a cell count and viability. Adjust the cell density of the suspension to  $2-5 \times 10^5$  viable cells/mL in the shipping medium.
4. Incubate the culture, horizontally, at  $37^{\circ}\text{C}$  in a 5%  $\text{CO}_2$  in air atmosphere. Maintain the cell density of the culture as suggested under the subculture procedure.

## Subculturing Procedure

### Medium Renewal: Every 2 to 4 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at  $2 \times 10^5$  cells/ml and maintain between  $1 \times 10^5$  and  $1 \times 10^6$  cells/ml.

## Cryopreservation Medium

### Cryoprotectant Medium

Complete culture medium described above supplemented with 5% (v/v) DMSO. Cell culture
