#### A SAFETY PRECAUTION

#### Unpacking & Storage Instructions

- 1. Check all containers for leakage or breakage.
- Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.



#### Frozen Cells Handling Procedure for Frozen Cells

# Part A. FROZEN CELLS Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back.

Dilute ampule contents with culture medium (see batch data above).



### Handling Procedure for Flask Cultures

#### Part B. FLASK CULTURES

Recommended Handling Upon Receipt:

Suspension Cultures: The culture flasks have been completely filled with medium for shipment. Remove the entire contents of the flask and centrifuge at 300 x g for 15 minutes. Resuspend the cell pellet as suggested under subculture procedure described above.



#### **Subculturing Procedure**

**Protocol:** Cultures can be maintained by addition or replacement of fresh medium. Start cultures at 2 X 10(5) cells/ml and maintain between 1 X 10(5) and 1 X 10(6) cells/ml.

Medium Renewal: Every 2 to 3 days



#### Comments

Spleen cells were fused with P3X63Ag8.653 myeloma cells.
