Description: High molecular weight genomic DNA isolated from the MCF-7 human breast carcinoma cell line.

Note:

The MCF7 line retains several characteristics of differentiated mammary epithelium including ability to process estradiol via cytoplasmic estrogen receptors and the capability of forming domes. Contains the Tx-4 oncogene.
