### Description

The ATCC NDM-1 Strains Panel (ATCC® MP-18™) is composed of six clinical strains expressing the New Delhi metallo-β-lactamase (NDM-1) gene, *bla<sub>NDM</sub>*. Each strain demonstrates multidrug-resistance to as many as 36 representative antibiotics in a variety of drug classes, including carbapenems, β-lactams, cephalosporins, quinolones, tetracyclines, glycolcyclines, aminoglycosides, and dihydrofolate reductase inhibitors.
