Preparation Procedure

1. Rehydrate contents of vial with molecular grade H₂O. DNA is dried in 1X Tris buffer.
2. Place vial at 37°C for 1 hour or at +2°C to 8°C overnight.
3. For more complete rehydration and to fully recover DNA incubate the sample overnight at 4°C while rocking, then incubate for 1 hour at 65°C. Resuspending the dried DNA in approximately 250 µl may give better results.

Quality Control Information

1. Fungal genomic DNA is provided in a dried form. Store at +2°C to 8°C upon receipt. Store at -20°C if stored for more than 6 months). **Note:** Do not store in freezers with a defrost cycle. This will expose the product to increased temperatures.
2. Concentration by PicoGreen® measurement was found to be approximately 5 µg.
3. Purity: OD₂₆₀/OD₂₈₀ ratio.
4. Integrity of DNA was determined by electrophoresis on a 1%

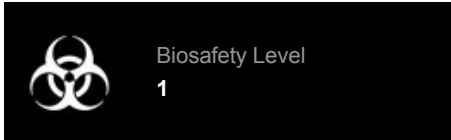
