### Growth Conditions

**Temperature:** 20.0°C

**Duration:** xenic; *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC 700831) and as a food source

### Protocol:

1. Scrape the bottom of the flask, quickly agitate and withdraw 0.2 ml of cell suspension.
2. Inoculate into 10 ml of ATCC medium 1525 bacterized with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC 700831).  
Note: the amoebae settle very quickly, so the transfer must be done very quickly to be effective.
3. Incubate the flask at 20C.

**Interval:** biweekly
