### Preparation Procedure

Ready to use, DNA is provided in solution with 1X TE.

1. Thaw the vial at room temperature.
2. Avoid exposing genomic DNA to repeated freeze-thaw cycles. Subjecting genomic DNA to repeated free-thaw cycles may result in degradation of the DNA and variations in copies/μL.

### Quality Control Information

1. Protist genomic DNA is provided in solution. Store at -20°C upon receipt.
2. Purity: OD<sub>260</sub>/OD<sub>280</sub> ratio.
3. Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe™, and was found to be intact and of high molecular weight (>50 kbp AMW).
4. No RNA was detected by electrophoresis.
5. Functional activity and identity of the genomic DNA was confirmed by PCR amplification of a 0.67 kb fragment of the species specific *Plasmodium falciparum* *msp2* gene and sequence comparison to other *P. falciparum* strains.
