## Comments

Suggest diluting 1:8 to 1:16 for agar gel double-diffusion. If antiserum (whole, unfractionated serum) is powdered, reconstitute in 0.5 mL sterile, distilled water; if liquid, serum is 50% glycerol. Virus is not mechanically transmissible.
