Antibody 107 is directed to epitopes of the virus known as neotopes present only on intact virus particles in a double antibody sandwich (DAS) type assay. It does not react with virus adsorbed to plastic in antigen coated plate ELISA because of particle degradation. The suggested dilution for use is 1:500,000 in DAS-ELISA using TMV polyclonal antiserum as capturing antibodies.
