No CPE, detect by immunofluorescence or molecular-based procedures

**Medium:**

EMEM (ATCC® 30-2003) + 10% horse serum (ATCC® 30-2040)

**Growth Conditions**

**Recommendations for Infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 60% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** Incubate infected culture for 4-21 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere.

## Comments

Derived from same strain by passaging in the absence of bovine serum. Passage infected cells for optimal propagation of virus.
