**Growth Conditions**

**Temperature:** 37°C

**Recommendations for Infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 70-80% confluent. Freeze-thaw viral material 6 times prior to inoculation. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 7 days

## Comments

JC polyomavirus hemagglutinates human type O red blood cells (HA requires addition of 0.25% sodium deoxycholate).
